## ACCESS CRITERIA

- At accepting the ticket, the visitor of the venue submits to the site rules (“rules of operation”), in the current version.
- Instructions of security staff and stewarding staff and the executive authorities must be complied with at all times.
- Access to and staying in the venue is allowed only at the times defined by the organizer without any exception. Staying overnight or camping in the venue is not allowed.
- Please keep to the marked paths. Standing on the stairs and emergency escape routes, climbing over and sitting on enclosures and barriers is prohibited.
- Animals or pets are prohibited.
- Motor sport events are loud. We urge you to wear ear protectors to minimize the risk of hearing damage. The organizer does not accept any liability in this regard. It is recommended not to bring children below the age of six to the event.
- Bringing along cold food (snacks), exclusively for your own personal use, is allowed.
- Persons obviously under the influence of alcohol or drugs are not allowed to enter the venue or can be removed from the premises and are not entitled to the ticket price being reimbursed.
- Persons not complying with the owner's site rules or acting suspicious by creating a disturbance can be removed from the venue at any time.
- The visitors are made aware that the venue is monitored by CCTV and these records may be used by executive authorities for criminal prosecution of any visitor.
- Pictures, videos, audio recordings and similar may only be taken for private and non-commercial use.
- Setting up and hanging up posters in the whole area including the courtyard is only possible upon express written approval by the owner or organizer.
- Distributing promotional material is only admissible upon previous written approval of the owner or organizer.
- Official merchandising items are sold within the venue. It is not allowed to buy goods from unofficial merchants. Furthermore, no goods of any kind may be distributed against payment or free of charge within the venue or in the parking lots.

### LIST OF PROHIBITED ITEMS

The audience is prohibited from bringing along objects of any kind that may be thrown or fired or which may be used to disturb or threaten the peace, order and security in the venue in any other way. This includes but is not limited to the items of the following list:

- Professional TV or video cameras and devices for professional audio recordings;
- Drink containers of any kind (except for unbreakable plastic bottles and customary cans);
- Grills, cookers and other devices for preparing food are not allowed;
- Weapons of any kind and objects that have a weapon-like effect, such as knives, darts, etc.;
- Objects and items that could be used as weapons or projectiles, including metal objects such as removable chains, iron bars and iron pieces;
- Laser pointers of any kind;
- Bringing along fireworks, Bengal lights, incendiary compositions, sticks, poles, parasols, glass bottles, rocks, objects that may be used as cut and thrust weapons and weapons of any kind is prohibited. Security staff and stewards are entitled to take away any such items at entry to the venue by inspecting containers you brought along or clothes;
- Pyrotechnical items of any kind;
- The use of an unmanned machine with a maximum kinetic energy of 79 joules /a model aircraft /an unmanned air vehicle from Class 1 (according to the Federal Law on Aviation (= LFG ));
- Gas-operated horns and other horns of any kind;
- Drugs and stimulants;
- Racist, xenophobic, right-wing extremist, Nazi, sexist or political propaganda materials;
- Animals;
- Any and all promotional, commercial, political or religious items, including banners, flags, signs, symbols, flyers and similar, as well as advertising and commercial objects and materials of any kind;
- Gas spray cans, caustic, inflammable, coloring substances or substances that are threatening a person's health or are highly flammable;
- Bulky objects such as scaffolding, ladders, bicycles, skateboards, scooters, segways;
- For access to the stands, bulky big bags, big backpacks, suitcases, sports bags are prohibited. Pursuant to this provision, all baggage is deemed bulky that could not be stowed away in the area of the purchased seat;
- Balaclava helmets or objects of a similar kind.

**LIST OF ALLOWED OBJECTS**

- Functional cell phones/mobile phones;
- Cameras, film and video cameras with batteries for private use and NOT for commercial use (e.g. NO video cameras suitable for TV);
- White canes, walking aids, wheelchairs;
- Key ring pendants, wallet chains;
- Medications (if proof of illness is provided, also including syringes and glass containers);
- Flagpoles of up to 1.3m or less than 2cm diameter;
- Customary pocket lighters;
- Binoculars;
- Plastic bottles and cans.

**IMPORTANT NOTE**

If light guns, rockets and/or firecrackers class II with more than 100 dB (e.g. "Supercobra 1-5", "Donnerschlag", etc.) or firecrackers class III and IV are found at access control, the persons bringing along such items are immediately prohibited from entering the premises.
